#### 1. Call to Order

#### 5. New Business

a. 2021 Actuarial Report

The Board was previously sent the findings of the 2021 Benefit Study by the actuarial firm.

The findings provided different scenarios, including raising dues. After much discussion, it was decided by the Board that no dues increase was necessary and that trying to increase participation would have the same impact.

- 1) In response to this, Dallas Connor made a motion to have a six-month open enrollment period begin in December.
  - a) Potential members who have less than ten (10) years on the department will be eligible to join the association with no "catch up" payments. Those over ten years tenure will have to pay the association an amount as determined by the Board.
  - b) Anyone who joins during this open enrollment period will not be eligible for financial assistance for one year.

Michell Combs seconded the motion and the motion passed.

#### b. <u>Discuss 2022 Contract Renewal with Segal Consulting</u>

The contract with our current actuarial firm expired in 2022. After discussion, Dallas Connor made a motion to not renew the contract after 2022. Tiffany Hayes seconded, and the motion carried.

1) It was decided that any future actuarial needs will be requested for a single report at that time, not an annual report as now.
